

Trent Temagami Weekend Sept 23-26 2010 Registration Form

(Drop off completed forms to the Kawartha World Issues Centre (KWIC) or fax to 705 944 5840)

The weekend takes place at Camp Wanapitei, a wilderness camp on Lake Temagami north of North Bay. www.wanapitei.net. We supply the food and cabins. There are 40 spots on the bus and registrations will be accepted on a first come, first serve basis. Your spot is only reserved once your payment has been submitted.

You need to be ready to hike and canoe in the outdoors and for fall weather. Keep in mind that conditions are rugged and the evenings can be cold (nights can get down well below zero °C). Most of the cabins are not heated.

All of your gear must be carried into camp down a 1 kilometer hiking trail. A backpack is highly recommended (rather than a suitcases or bags with wheels). Bring enough gear to stay warm and dry. If you are unsure about what to bring, ask us or someone who has been on the weekend before.

- Warm sleeping bag (at least a -7 °C rating) or two warmer rated sleeping bags.
- Water Bottle
- Rain gear & hat
- 2 pairs of footwear (one that will get wet)
- Warm jacket, sweater, socks & pants
- Toque!
- Bathing Suit & Towel
- Flashlight
- Lifejacket.
- Musical instrument: Guitars, violins, flutes, accordion, etc.

The fee covers the bus from Trent, accommodation, canoes, paddles, and all meals, except lunch on Thursday (bring a bag lunch or purchase in North Bay) and supper on Sunday (usually bought at restaurants in Huntsville on the way back).

Please note that every participant is required to read and sign liability waivers for both Trent & Wanapitei and submit these with their registration. If you have any questions please email trish@wanapitei.net.

We depart from the parking lot behind Champlain College at 9 am sharp on Thursday September 23 (be there by 8:30am to load the bus) and return sometime after supper on Sunday the 26th.

I acknowledge that I will be traveling to and from Trent University to **Wanapitei Wilderness Centre in Temagami and** other locations by means of vehicle transportation provided or authorized by Trent University between September 23-26th 2010.
